1. Project Background

- The Oman Government aims to enhance public service delivery by continuing the operation, maintenance, and enhancement of the existing E-Government Portal: "Oman Business Platform".
- 2. This initiative aligns with Oman's Vision 2040, emphasizing digital transformation and improved government efficiency.
- The portal currently serves as a one-stop platform for citizens, residents, and businesses to access government services online.



2. Project Objectives

- Attract Foreign Direct Investment (FDI): Prioritize FDI by giving investors easy access to processed and analyzed information.
- Ease of Doing Business: Streamline business procedures to simplify registration, compliance, approvals, and licensing.
- Enhance Investor Experience: Provide an advanced platform with comprehensive information, minimal navigation, and fast processing.
- Supporting SMEs and Start-ups.



2. Project Objectives

- Expand Platform Usage and Revenue: Introduce new services to improve portal efficiency and quality.
- Improve E-Government Rankings: Enhance Oman's positions in key e-Government indexes.
- Generate In-Country Value (ICV): Focus on Omanization through training, key role inclusion, SME support, and job creation for locals.



3. Platform Overview

Oman Business Platform

- · It is an online portal.
- previously known as Invest Easy, One Stop Shop.
- launched in 2014 by the Ministry of Commerce, Industry and Investment Promotion of Oman.
- To enable business owners and investors to start and complete business procedures interfacing the government efficiently, quickly and easily.



4. Platform Technical Specifications

- Application Stack: The Oman Business Platform uses application servers, load balancers, Oracle 19c databases, document management, and Activiti Framework for rule and workflow management.
- Technical Infrastructure: Features high-performance messaging with LMAX Disruptor, secure SMS/email via OpenSmpp and JavaMail API, and file management with XADisk, supported by a hybrid on-premises and cloud server infrastructure.
- Integration and Security: Integrates via RESTful and SOAP web services, with PKI-based smart card authentication and strict data protection compliance per Ministry standards.



5. Project Requirements

To ensure the continued success and enhancement of the E-Government Portal, the Project requirements the new vendor to provide comprehensive services in several key areas:

- Implementation and Operation: The vendor should handle platform development and compliance, technology management and innovation, cloud services, data management, user support, and performance monitoring.
- Planning and Design (Continuous): Provide ongoing strategic innovation, planning workshops, and technology advancement and integration.
- Training and Capacity Building: Focus on expertise development, knowledge transfer, and comprehensive training programs.



6. Procurement Strategy

The procurement process will adhere to Oman's Public-Private Partnership (PPP) Law and Regulations.


- EOI Stage: Expression of Interest (EOI) where vendors express their interest in the project, initiating the procurement process. (Ended in 12th Nov 2024)
- Request for Qualifications (RFQ): A pre-qualification stage to shortlist vendors based on their capabilities.
- Request for Proposals (RFP): A competitive tender stage for shortlisted vendors to submit detailed proposals.

The process follows Oman's PPP Law, with the government seeking a vendor or consortium experienced in large-scale IT projects and e-government solutions. Evaluation will focus on technical expertise, financial stability, innovation, and alignment with the project vision.
